# **INTRODUCTION, TIMING AND PURPOSE:**

This policy is to establish guidelines and set a fee schedule for the installation, removal and storage of boat hoists for Ma-Me-O Beach ratepayers. To control costs and prolong the use of the Village tractor, these guidelines will be followed.

An agreement which forms part of this policy will capture pertinent ratepayer/boat hoist information and outline the process used to ensure public safety, manage municipal risk and effectively perform this service.

Property ratepayers who wish to participate in the boat hoist program must pay their entire fees by May 15<sup>th</sup>, of the current year.

The Summer Village will accept NO liability for damages to any boat lifts.

### **GUIDELINES:**

- 1. Any Ma-Me-O Beach ratepayer may request a boat hoist be installed, removed and/or stored.
- 2. A current boat hoist agreement MUST be fully completed, signed, and paid prior to any service(s) being rendered.
- 3. Fees are set at:

#### Installation

Small Hoists (10ft x 10ft)	\$80.00 includes GST.
Docks (per section)	\$80.00 includes GST.
Piers	\$80.00 includes GST.
Large Hoists (greater than 10ft x 10ft)	\$145.00 includes GST.

### Removal

Small Hoists (10ft x 10ft)	\$80.00 includes GST.
Docks (per section)	\$80.00 includes GST.
Piers	\$80.00 includes GST.
Large Hoists (greater than 10ft x 10ft)	\$145.00 includes GST.

# Storage

Storage per unit is \$35.00 includes GST, if stored in Day Park or Summer Village.

- 4. The Summer Village of Ma-Me-O Beach will perform the initial installation of the boat hoist. A one-time adjustment for placement of the hoist will be done at no extra charge. Thereafter, any adjustments will be \$80.00 includes GST.
- 5. There will be an additional \$30.00 includes GST penalty for registration and payment received after May 15<sup>th</sup> deadline.
- 6. The ratepayer MUST MARK AND IDENTIFY THEIR HOIST in accordance with the regulations pursuant to Transport Canada *Navigable Waters Protection Act (NWPA)* Program with permanent markings or weatherproof paint. The boat hoist must clearly be identified with the owners name and municipal address and be marked with appropriate yellow reflective tape to identify the hoist location in darkness.
- 7. Hoists can not be placed more than 30 meters from shore, at a depth of more than 30".
- 8. The Summer Village Office will coordinate the process with the Public Works Foreman. All instructions and work requested of the Public Works Foreman must be directed to the Summer Village Office.
- 9. All installations and removals will be dependent on Good Weather and Safe Conditions.
