As Winter ends, Spring is right around the corner! The Village Office is currently preparing for the Boat Hoist Program once again for Ma-Me-O Beach ratepayers. To participate in the program, please return the following to the Summer Village Office by May 15<sup>th</sup>, 2022:

- A completed and signed 2022 Boat Hoist Agreement including a signed copy of the Terms and Conditions Agreement;
- Payment for the Total Fees can be made in person via cash or cheque, online through your tax account using your roll number, or credit card/debit card. To use your credit card/debit card go to the Ma-Me-O Beach website ([www.mameobeach.ca](http://www.mameobeach.ca)), from the home page click on the **\$** above 'PAYMENT OPTIONS' where you will find the listing of payment options.

**Please note:**

- The submission of incomplete forms or a delay in payment will impact the installation of your hoist.
- All hoists in the program must be marked by the Summer Village, in accordance with the regulations pursuant to Transport Canada *Navigable Waters Protection Act (NWPA)* Program with permanent markings or weatherproof paint. Hoists will be marked with an identification number (which will be provided to the owner for reference and the Ma-Me-O Beach logo) Regardless of whether the hoists owner participates in the program, all hoists must be labelled in the same manner.
- Hoist owners are asked to apply reflective tape to their hoists to improve visibility in low light conditions and use appropriate yellow reflective tape to identify the hoist location in darkness.
- Hoists will be placed in the water up to a depth of 30 inches, this distance will vary based on sandbars.
- All instructions, work requests, questions or concerns should be directed to the Summer Village Office to ensure effective and timely attention.
- All installations and removals are dependent on weather and safety conditions.

**Please note:**

- A small hoist is 10' x 10'
- A large hoist is larger than 10' x 10' or has a canopy
- Hoists cannot be placed more than a depth of more than **30 inches** and must have 4 sides marked with yellow reflective tape or lights.
- Hoists must be marked with their hoist number in **BRIGHT** spray paint by the Summer Village.
- All Hoists must have the Ma-Me-O Beach logo marked on them by the Summer Village.
- All fees include GST. Please make cheques payable to '**Summer Village of Ma-Me-O Beach**'
- Residents can pay in person via cash or cheque, online through their tax account using their roll number, as well as online via credit card. # TERMS and CONDITIONS

## INSTALLATION

1. This agreement is to be completed and returned to the Ma-Me-O Beach Summer Village Office by May 15, 2022 with payment of fees. **A late fee of \$30.00** will be added if your agreement is received after May 15, 2022. **Int.**
2. Hoists cannot be placed more than a depth of more than **30 inches** (to reduce risk of damage to tractor) and must have 4 sides marked with yellow reflective tape or lights. **Int.**
3. The Boat Hoist must be in the upright position, during installation and removal, to help eliminate damage. The cradle must be raised as high as it will go. **Int.**
4. Boat Hoists will be identified by Village Staff with your hoist # well above the water line on the beachside of the hoist. As per Guideline #6 of policy #14-2009. **Int.**
5. If required, one positioning change will be provided **during initial spring installation**. Any additional positioning changes will be charged at a rate of \$80.00. Payment must be provided in advance for additional positioning changes. **Int.**
6. All installation and Removal of all Boat Hoist is dependent on weather and safe conditions. I understand that the boat hoists will be placed in the water strategically, observing the location requested by the owner as closely as possible while maintaining the safety of the contractor conducting the work. **Int.**

## STORAGE

Boat hoists may be stored for a storage fee of \$35.00 on Municipal Property between September 1<sup>st</sup> to May 31<sup>st</sup> with authorization from the Summer Village Office. Please indicate on your agreement if you are storing your hoist on private property and indicate the address.
