## **Wastewater System Information for New Property Owners**

## Background

The Summer Village of Ma-Me-O Beach has a Municipal Wastewater Utility System that provides wastewater services to residents of the Summer Village. The system is a low pressure effluent system that pumps effluent to the Regional wastewater lines and through to the Mulhurst Lagoon.

At the time that the wastewater system was installed, Council did not want to place a financial burden on existing property owners and allowed property owners to choose to connect to the new system or continue to pump out their holding tank.

## **Current Situation**

The use of the system is governed under two Bylaws. Wastewater Bylaw #362 requires that properties that have not connected to the system have their holding tanks inspected every third year at the property owner's expense.

Municipal Wastewater Utility Bylaw #382 requires that new property owners connect to the wastewater utility system within one year of a successful system activation and winter operation. At this time, we expect this to be June 2024.

If the property you have recently purchased is not connected to the system, this letter is Notice to you that your connection to the system must be completed within one year of successful system operation. This is expected to initially occur in June 2024.

If the property you have recently purchased is connected to the system, this letter is Notice to you that you are responsible for adhering to the requirements as set out in the Municipal Wastewater Utility Bylaw # 382. This bylaw is posted on the website at www.mameobeach.ca. You may wish to become familiar with the requirements of this bylaw including the following: Property owners are required to ensure that:

- - a) all wastewater including greywater is directed to and contained within the holding tank;
  - b) the tank and discharge lines from the residence remain watertight and in good condition;
  - c) rain water, sump discharge water, and surface water do not enter the Summer Village system;
  - d) the first compartment of the holding tank is pumped out on an as-needed basis;
  - e) no prohibited materials enter the Summer Village system; and,
- f) inspectors appointed by the Municipality have free and reasonable access to the property for the purpose of inspecting and monitoring the Summer Village system.

Please note that the Municipality may temporarily shut off these services, without notice, to undertake necessary repairs, in an emergency, or if the Chief Administrative Officer considers the reason sufficient.

No person shall hinder, interrupt, or cause or procure to interrupt the municipality or its contractors, agents, employees in the exercise of the power and duties related to the wastewater services and authorizations contained in this agreement.
