Land Use Bylaw Consultation Process


Your feedback is vital, please take the time to share your thoughts and concerns.

Wastewater Project Overview

In 2016, the Summer Village of Ma-Me-O Beach entered into a partnership with the Summer Villages of Norris Beach, Crystal Springs, Grandview, Poplar Bay and the County of Wetaskiwin to complete a South Side Regional Wastewater System. They collaborated in an application under the Building Canada Grant to complete the project. The Me-Me-O Beach project was approved under the Phase I grant at an estimated cost of approx. \$3 million.

The project was approved with the understanding that it could be completed using available grant funding and reserves within the Summer Village. There would be no additional cost to ratepayers except for the cost to connect a proper 2 chambered tank with heat trace to the service line. The project scope included the heat traced main lines and the service connections to each lot.

The Summer Village awarded the tender for engineering design and construction to MPE engineering. In June 2017 PME Inc. ("PME") and the Summer Village entered into a contract for the construction of the Wastewater System.

In February 2019, the wastewater froze in the force main due to the failure of the Electrical Heat Trace (EHT) System. To date, PME has failed to remediate the EHT System and the Summer Village and its connected residents have not been able to rely on the EHT System.

PME declared the contract to be repudiated and proceedings for arbitration as defined under the contract commenced.

In the summer of 2020, the Summer Village engaged RMRF to represent them in the arbitration proceedings. Since then, where possible, the Summer Village has operated the system during the warm season. It became apparent that the Summer Village would need documentation of the conditions before it could prepare arbitration/ counterclaim information.

The Summer Village hired WSP engineering to conduct an investigation of the heat tracing failure. In Feb 2021, the WSP heat tracing report identified both heat tracing issues and civil issues related to the wastewater system installation. The arbitration hearing, originally scheduled for November 2021 was deferred to June 2022 to allow the Summer Village time to complete the investigation. The Summer Village decided that the best way to identify issues was to begin the rehabilitation and document all of the issues found.

In August 2021 the Summer Village began remediation of the system through time and materials contracts with Dart Electrical and THS Septic Solutions, with WSP as the documentation and construction administration engineering firm.

The Summer Village did not have sufficient funding to move forward with the construction and was unable to secure any additional grant funding.

Wastewater Project Timeline cont...

The Summer Village borrowed a total of \$2.9 Million to complete the rehabilitation to date. The intention was to complete a section of the system (approx. 24%) between Jubilee Park and 11 Street to run over the winter as a test section.

In August 2022, the Summer Village was advised by the civil contractor that they were unable to complete the section at 11 Street due to staffing issues and the high water table. Without the completion of the civil work, the heat tracing could not be rehabilitated, and the system cannot be heat traced for the winter. As the cost to bring on a new contractor exceeds the funds available, the trial has been deferred.

The active system will be shut down in the fall and re-activated in the spring. The arbitration process is on-going and expected to be complete in December. At that time, depending on the award amount under the arbitration, council will make decisions regarding next steps in the construction.
