<u>2023 Property Assessments</u> – The property assessment in Ma-Me-O Beach based on the *Valuation date* of *July 1*, <u>2022</u> shows an overall average increase of **5.2%** as compared to the same date in 2021.

Overall 2023 Property Taxes increased by 2.1% compared to 2022 levels.

Municipal Property Taxes increased by 2.5% (\$12,008) to \$492,329 compared to 2022 (\$480,321) The Provincial School Requisition increased by 1.3% (\$3,445) to \$271,000 compared to 2022 (\$267,554) The minimum tax payable remains the same at \$800.

<u>Wastewater Levy</u> - As per our agreement with the County of Wetaskiwin, an annual fee is collected as a separate levy on your tax invoice. The 2023 Annual Levy remained at \$150 for Residential and \$190 for Commercial.
